
Priorities

ESA Priorities

- **Steady progress**, with a recognition we can't solve this problem all at once
- **Increasing efficiency** of BE development and consultation
- **Transparency**
- **Opportunities for Stakeholders** to be part of the solution
- **Refined Maps** to narrow geographic restrictions to only those areas needed to protect listed species
- **Early proactive mitigations** to protect listed species from pesticide exposure
- **Flexible and Implementable** Mitigations for pesticide users
- **Off-sets** as another tool to minimize impact on pesticide users and protect species

Hiring Update

- Overall, in FY 2023 EPA brought on 50 staff and 53 staff left OPP (this includes detail assignments to/from OPP);
- Status of new hiring activity (excludes details):
 - OPP hired 30 new people in fiscal year 2023;
 - OPP experienced a loss of 40 people in FY23;
- In the calendar year since passage of PRIA 5 (January through December 2023) OPP hired 35 new people and 34 departed.
- In FY 2024 as of the end of February, OPP had hired 17 new employees and had 15 employees depart.


FY24 Appropriations and Fee Collection Impact

- For FY24, the Presidents' Budget requested **~\$172 million** from Congress for the pesticide programs at EPA through the Environmental Programs and Management (EPM), Science and Technology (S&T), and State and Tribal appropriations
- Congress only provided overall funding of **~\$121 million** through these appropriations
- This funding level is almost **\$37 million** below the FY24 Pres Bud
 - Also represents a cut of **\$5.155 million** from these FY23 Congressionally Enacted appropriations
- This cut is significant to our programs
 - For context, this \$5.5 million decrease in funding represents 25.8 FTEs (federal employees) or contractor equivalents for the year.
- FY24 PRIA fee collections are significantly less than anticipated (**~\$6 million**)
- The significant decrease in resources negatively impact our programs' ability to manage the workload and subsequently time to complete actions will worsen


Appropriations

- PRIA minimum appropriations level: **\$166,000,000**
- FY 2023 Final budget: **\$138,646,000**
- FY 2024 Final budget (projection): **\$132,464,000**
- FY 2025 President's budget:
 - STAG: \$14,027,000
 - EPM: \$150,000,000
 - S&T: \$11,000,000


Pesticides Enacted Appropriations by Fiscal Year, FY 2012-2024 (Dollars in Thousands)



Amount Funding (\$Million) Below Minimum Appropriation Level (FY 2012 - FY 2024)




EOY Total FTE Usage Assuming FTE Cuts and Holding Current Contract Spending Constant

PREP Update

- **Pesticide Regulatory Education Program (PREP)** – OPP program designed for states, tribes and territories to train pesticide managers on key pesticide issues of national significance, and to foster strong relationships and information sharing between coregulators.
- **2024 Season Line-up:**
 - Certification & Training PREP – April 22-25th, Fort Collins, CO
 - Compliance & Enforcement Management PREP – June 24-27th, Davis, CA
 - Pesticide Labels From Registration to Enforcement PREP (**new course**)
August 5-8th, Fort Collins, CO
 - Laboratory Issues PREP – September 23-26th, Denver, CO
- **Behind the scenes** – The PREP Team formed a small workgroup to consolidate all historical data and develop an easier system for future data entry and management.

PIRT Update

- **Pesticide Residential Training Program (PIRT)** – OECA program designed for states, tribal and territorial inspectors that typically funds two national pesticide classroom courses a year.
- **Upcoming Course:** Pollinator Issues PIRT, July 15-18, 2024 in Raleigh, NC.
 - Registration will open in late spring/early summer.
