**A. Agenda Item: National Topics Roundtable:**

States reviewed the following topics suggested by SFIREG leadership for national consideration:

- 1. EPA Label Amendment Cover/Acceptance Letters** – General consensus to move away from instructions on acceptance letters with general concern relative to enforcement as enforcement is central to the actual label.
- 2. General use pesticides that are reclassified to RUP** – After review and discussion there may be a need to improve communicating re-classification activity, specifically, reclassification of a general use pesticide to a restricted use pesticide. In discussion, in addition to certification regulations elevating in response to a pesticide re-classification, there are other activities that may be evoked, such as disposal and training.
- 3. Pesticide Registration Decisions** – Length of time for federal review concern; inquiry as to status of mancozeb, captan, and final decision on rodenticide.
- 4. Mosquito control back-pack mist blowers** – Continuing review supported. States noting that complaints continue to be received relative to mosquito treatments.
- 5. ESA Workplan and Strategy Implementation** – Continuing discussion point; state's identify different stages of outreach; implementation guidance requested.
- 6. Bulletins Live Two (BLT)** – Question relative to how Pesticide Use Limitation Areas are defined; what are on-going efforts to refine delineations?
- 7. Implementation of the Final Biological Opinion on Carbaryl** – States encouraged to submit concerns as identified.

- 8. Feed-through pesticides** – States encouraged to identify any issues with specific products. No immediate concerns were noted.
- 9. New and Ongoing Issues** – Ongoing issues supported; no suggestion for new white papers or issue papers.
  - a. Rodenticide** – In depth discussion of rodenticide regulatory action at state-level and nationwide. An EPA summary of PID and ESI to address rodenticides and anticipated additional actions would be helpful.
