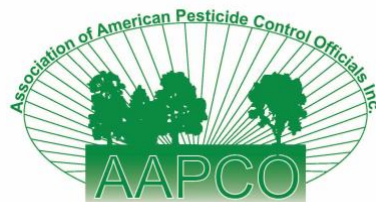
The process of registration of pesticides is the fundamental mechanism for effective pesticide regulation. Registration decisions regarding active ingredients, safety precautions, directions for use, environmental protections, and cautionary language affect every aspect of state pesticide regulatory programs. EPA has recently established a goal of reducing the backlog of registration decisions and begun process improvements to make decisions on registration of new active ingredients and re-registration decisions more quickly and efficiently. This increase in the tempo of registration actions has a direct impact on SLAs requiring more effort to evaluate registration decisions and their impact on compliance programs. This session will explore the changes EPA is implementing to increase the tempo of registration actions, what SLAs can expect in the near future, and how SLAs can stay informed and involved in registration decisions.

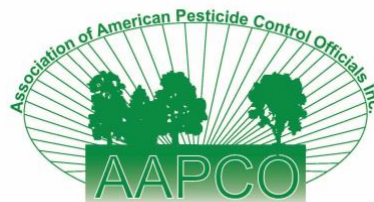

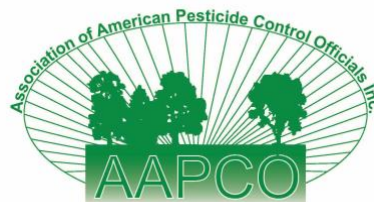

8:00 am **Overview of the UAPASTF: Industry Data Supporting UAV Labeling** – Dr. Travis Bui, Corteva Agriscience
The Unmanned Aerial Pesticide Application System Task Force (UAPASTF) was established in response to recommendations from the Organization for Economic Co-operation and Development (OECD) Working Party on Pesticides' 2021 report on the use of Unmanned Aerial Spray Systems (UASS) in agriculture. In addition to generating data to evaluate off-site movement, the UAPASTF has been actively addressing non-dietary exposures from UAV applications and in the development of best practices related to safe use of pesticides in UAV applications. This presentation will summarize the on-going work of the UAPASTF as it relates to the overall regulatory process, and its use in the development of UAV-specific labeling.
